#### **April is Child Abuse Prevention Month.**

Large numbers of small children are assaulted and battered daily in North America. Many die from their wounds. It is legal to hit a child (euphemistically known as "corporal punishment") as long as the child is your own. In 19 states, schools can hit children with big boards. These boards cannot be transported by passengers on airplanes because TSA classifies them as weapons.

#### April is also Sexual Assault Awareness Month.

Despite their outcries, children are judicially trafficked into the arms of incestuous parents. Two studies show 90% of children are not protected by courts when identified perpetrators ask for custody, even though research shows that well over 90% of children are not fabricating the abuse. Because of the similarity and pattern in cases, it is clear there is an undeclared war against children. Please help us expose and end this scourge.
