URGENT: Seeking Submissions for a New United Nations Petition!

The Women's Coalition Activists petition to the United Nations last year was successful. The U.N. Commission on the Status of Women (CSW) just released their 2016 annual report, which officially recognized the discrimination against women resulting in custody being taken away from mothers and given to fathers as a prevalent human rights issue. A special thanks to the 150 women who submitted their cases by filling out the form!

The Women's Coalition is submitting another petition this year, asking the CSW to go beyond recognizing the discrimination and make a report about it to the Economic and Social Council [ECOSOC], which is the main organ of the U.N. capable of taking action to educate about and eliminate this discrimination.
